All vendors are required to complete set up by 7 a.m. on Saturday, April 2nd (no lighting in the vendor area)

No refunds will be issued after payment is received (including those due to weather).

Applying or being a vendor in the past does not ensure acceptance. The committee reserves the right to turn down any application for any reason.

*Specific locations will be emailed 1 week prior to the festival. You must arrive on time, and no refunds will be issued to vendors that are late. **There is also no rainy-day plan for the festival. Please keep this in mind when applying and before sending in your money. This is firm and non-negotiable.** We apologize for any inconvenience.*

Submitting the application is an agreement to the following:
